Main tasks and responsibilities: • Be responsible for designing, implementing, evaluating, coordinating and managing occupational hygiene programmes to meet legal, compliance and ensuring a safe and healthy working environment • Plan, develop, implement and manage hygiene programmes • Evaluate and assess risk • Design and implement guidelines • Review and ensure appropriate working conditions at the mine/operational areas • Establish and operate a system to understand and mitigate occupational hygiene and ergonomic hazards (according to MHSA) requirements • Compile and update occupational health risk matrix • Identify hazardous conditions and practices proactively • Analyse and evaluate conditions and practices and oversee the rectifications thereof • Ensure that physical audits and inspections are conducted • Determine the effectiveness of implemented controls by developing checklists and ensuring correct controls where necessary • Compile and submit reports to authorities • Provide input into SHERQ scorecard • Ensure effective laboratory management and provision of services • Design and implement long-term ventilation plans and systems • Ensure that precautionary measures are taken to prevent or suppress explosions and that adequate measures are in place to prevent, detect and combat the start and spread of mine fires • Implement remedial action in such instances where hazardous conditions and practices were identified and evaluate the impact to ensure remedial actions are effective • Ensure that over exposures are investigated and that the relevant reports are submitted to line management in a timely and accurate manner.

Minimum requirements (essential unless otherwise indicated): • Grade 12 • BTech Occupational Hygiene or Diploma: Public Health with specialisation in Occupational Hygiene or Diploma: Environmental Health (with specialisation in Occupational Hygiene) • Certificate: Advanced Mine Environmental Control • Professional Status: Hygienist (SAIOH) • Code E/EB driver's licence • 2 years' management experience • 8 years' Registered Occupational Hygienist experience in a similar environment • 3 years' ventilation control, operations and management systems experience • Systems experience which includes Microsoft Office and SHERQ systems.
