PLANT MANAGER: The purpose of this position is to plan, direct and manage all operational activities within the Minopex area of responsibility to ensure adherence to contractual requirements, provide value-add to the client and continuously improve the service delivery according to organisational objectives. Requirements: Bachelor's Degree or Diploma in Metallurgy or Chemical Engineering / Degree or National Diploma in Engineering including possession of a Government Certificate of Competency (GCC). Minimum 10 years' experience in a processing or engineering environment. Minimum of 5 years in senior management level. Ferrous Metal and Dense Medium Separation processing experience will be an added advantage.

Valid section 13 Trade test / Section 26(D) certificate required plus minimum of 2-3 years' experience as a qualified Artisan in a DMS plant (preferable). Valid driver's licence code B, EB or C1 with own transport to attend to call outs. Must have experience in pump maintenance and repairs; able to do equipment alignment; have knowledge in changing bearings.

ENGINEERING ARTISAN – BOILERMAKER: The purpose of this position is to diagnose and maintain machinery and equipment according to technical specification and sound engineering practice. Requirements: Grade 12 or equivalent qualification. Valid section 13 Trade test / Section 26(D) certificate required. 2 years' experience as a Boilermaker in a DMS environment is required. Able to do CO2 welding and to fabricate pipe work of any size pipe. English Language Proficiency. Valid driver's licence code B, EB or C1 with own transport to attend to call outs.

ENGINEERING ARTISAN INSTRUMENT TECHNICIAN: The purpose of this position is to maintain plant systems and equipment according to instrumentation and technical requirements. Requirements: Grade 12 or equivalent qualification. National Diploma S4 Electrical Engineering – Light Current. Entry level up to 5 years' experience as a Technician. English Language Proficiency. Valid driver's licence code B, EB or C1. Must be able to do PLC programming; have experience in AScii installations; VSD trained; and experience in one of the following smart relays (Siemens, Allen Bradley, Schneider). Knowledge of belt scale maintenance, actuated control valves, and magnetic flow meters. Must be able to work in confined spaces and at heights. Must be familiar with risk assessment procedures. Not colour blind. Having a Mechanician trade qualification will be an added advantage.

ENGINEERING ARTISAN – **ELECTRICIAN**: The purpose of this position is to diagnose and maintain machinery and equipment according to technical specification and sound engineering practice. Requirements: Grade 12 or equivalent qualification. Valid section 13 Trade test / Section 26(D) certificate required. Minimum of 2-3 years' experience as a qualified artisan with at least 2 year's DMS plant experience. English Language Proficiency. Valid driver's licence code B, EB or C1 with own transport to attend to call outs. Medium voltage competency skills (certificated). VSD trained. Experience in one of the following smart relays (Siemens, Allen Bradley, Schneider). Must be able to work in confined spaces. Not colour blind. Knowledge of maintaining MV motors will be an added advantage.

STOREMAN: The purpose of this position is to issue and receive goods according to Minopex requirements and Stores Procedures. Requirements: Grade 12. At least 1 years' experience in a stores environment. Forklift licence will be required and a valid driver's licence code B, EB or C1.

PLANT ADMIN COORDINATOR: The purpose of this position is to provide secretarial, clerical and administrative support to the Plant in order to ensure that an effective and efficient administrative service is provided. The incumbent will also provide procurement and buying support for the site. Requirements: Grade 12 with an Accounting/Payroll qualification. Secretarial Diploma. 5 years' experience in a secretarial / office administration role is required, preferably in the mining or process plant environment. Minimum 2 years' experience in a payroll and accounting environment. Computer literate in MS Office.

CONTROL ROOM OPERATOR: The purpose of this position is to be responsible to continuously monitor all process parameters to ensure safe and effective operation of the production Plant according to operating procedures and standards. Requirements: Grade 12 with Maths and Science. National Certificate Mineral Processing Level 2 or equivalent Mineral Processing qualification. Minimum 3 years' experience as a process operator. Minimum 2 years control room operation experience. DMS Plant experience advantageous. Scada system competent.

PROCESS SHIFT SUPERVISOR: The purpose of this position is to be responsible for the effective supervision of the required shift to ensure that shift processes are operational, controlled and maintained. Requirements: Grade 12, Maths and Science advantageous. National Certificate Mineral Processing Level 4 or equivalent Minerals Processing Qualification. Knowledge and understanding of DMS operations advantageous. Minimum 3 years' experience as a Plant Operator. English Language Proficiency. Computer Literate in MS Office. Valid driver's licence code B, EB or C1. Familiar with SHEQ and maintenance systems controls and management. Familiar with Control Room protocols and Scada systems operation.
